INTRODUCTION

The Giacomo Puccini APS Choral Society of Grosseto, based in Grosseto, Via G. Reni 13 (Tax Code 80001980533- VAT number 01349140531), pro-tempore President Dr. Girolamo Lubrani, organizer of the Choral Composition Competition called "Puccininsieme a Il Sommo Poeta", first and non-profit edition, reserves the right to preview the winning compositions and those reported by the Jury, during the concert at the Theater in Grosseto which will take place in November 2021 with the right to publish, including recordings, of the winning compositions. The proceeds from any publication, after deducting the author's rights and the costs of production and the competition event, will be donated to the Association or Body identified by the Board of Directors of the organizing Choral.

Any resumption, recording, transmission, in whole or in part, on the internet or by radio and / or television broadcasters, as well as on their own, of the final phase of the Competition, including the performance of the winning pieces of the Competition or otherwise mentioned, will be disclosed for the promotional purpose of the event organized, for the first time, on the occasion of the 700th anniversary of the death of Dante Alighieri and to facilitate the collection of funds for charity.

The Soc. Corale Giacomo Puccini Grosseto APS is expressly authorized to use the biographical information and images of each individual winner of a category or otherwise mentioned for exclusively promotional purposes of the event.

CONDITIONS AND TERMS OF SERVICE

The publication and / or subsequent disclosure of the audio / video recordings made) during the final phase of the Competition (preview performance of the winning and / or mentioned pieces), is subject to the full acceptance of the following conditions and terms.

The subscriber of this release, by registering for the "Puccininsieme a Il Sommo Poeta" Competition, transmits and sends the piece composed to the Puccini Choral Society, as indicated above, organizer of the event: the authorship of the composition sent is and remains of its Author.

The participating composer explicitly agrees, without prejudice to his rights (SIAE or others):

- the eventual publication of the score and in digital and / or paper format by the organizing Choral Society if the work is the winner of a category and / or has been possibly reported;
- the preview performance by the organizing Choral Society if the work is the winner of a category and / or has possibly been reported;

- to any publication, including by record or by other means, by the organizing Choral Society, also on YouTube and on the website of the organizing Choral, if the work is the winner of a category and / or has been possibly reported.

The aforementioned conditions and terms of use are all informed by the absolute and complete gratuitousness of the service offered which corresponds to the absolute and complete gratuitousness of participation in the competition and the use of the piece presented in the competition by each individual member.

The character of the total gratuitousness, without prejudice to the Author's rights (SIAE or other), remains even on the occasion of the diffusion of the same through the audio CD containing the pieces indicated in the introduction.

Therefore, the general conditions and procedures referred to in the announcement / regulation of the Choral Composition Competition "Puccininsieme a Il Sommo Poeta", first edition, already approved by signing at the time of registration for the competition itself, are referred to herein.

The subscriber acknowledges, declares and guarantees:

- to be of age / s; otherwise, the operator signs the parental authority over the same registered in the minor competition;
- to have personally provided, at their own expense and responsibility, for the transmission and delivery of the material sent to the organizing choir;
- to be aware that by sending the aforementioned material and by accepting these conditions and terms, he grants to the Choral Society the right and the license, not subject to any remuneration and as such completely free and non-exclusive, to use , adapt, publish, distribute, reproduce and perform without territorial and / or temporal limitations within the limits of the law, the material transmitted and the recordings made during the phases of the Competition, and in general, to exercise all rights - direct and / or indirect - exploitation and use of the material transmitted and of the recordings made during the phases of the Competition in order to raise funds for benefits;
- recognizes the Choral Society the right to reproduce, memorize, disseminate and publish by means of audio CD the recordings made during the stages of the Competition for the joint purpose of raising funds and indeed expressly authorizes it to do so;
- acknowledges that the Choral Society may modify or vary at any time and at its sole discretion the conditions and terms of use of the service and / or transmission of the composition and the recordings made during the stages of the Competition without prejudice to the absolute total and complete gratuity of the service offered which corresponds to the absolute and complete gratuity of participation in the competition with the exception of the registration fee required for the purpose of participating in organizational costs;
